**SPONSORING MEMBERS**

The Chattanooga Rifle Club requires that all new members have a sponsoring member. The sponsoring member **MUST** be a member in good standing for three (3) or more consecutive years. If a new applicant does not know an eligible Club member, the applicant can be interviewed by the Board of Directors which **MAY** then become his/her sponsor.

**PAYMENT OF CLUB DUES**

New applicants must complete this application and return it to the club address on the front of this application. The pro-rated first year's dues, initiation fee, and access card fee shall be paid at the **New Members' Orientation**. Applicant will be contacted about this amount by phone. Payment must be in the form of a check or money-order. We do not accept cash or credit cards.

**ORIENTATION**

CRC requires that all new members attend a **New Members' Orientation**, at the Club, so they can learn about the Club's layout and become familiar with the Range and Safety Rules. Prospective members will be contacted about their Orientation by phone and email.

**ABOUT CHATTANOOGA RIFLE CLUB**

The Chattanooga Rifle Club has been in existence since the early 1900's. The CRC has been affiliated with the NRA since 1927 and incorporated since 1947. The club has a long and active history of promoting safety, marksmanship, and competitive shooting activities for both rifles and pistols. These activities are suitable for all family members. Also, each member is afforded nearly unlimited use of the most extensive shooting range facilities in the area. Briefly, the ranges include: a 100 yard competition range with 50 covered firing points; 200 & 300 yard high-power rifle ranges with 8 firing points; a plinking range; and a pistol range with 27 covered firing points. The Club ranges are located on Hunter Road, off of Tennessee State Highway 58, in Hamilton County, near Chattanooga, Tennessee.
